<b>Corrosivity</b>	Corrosive in presence of steel, of aluminum, of zinc. Non-corrosive in presence of glass, of copper, of stainless steel(304), of stainless steel(316).
<b>Special Remarks on Reactivity</b>	Moisture Sensitive. Light Sensitive. Air Sensitive. Air causes decomposition to iodine. Reacts violently with strong oxidizers, bromotrifluorides, chlorotrifluorides, fluorine perchlorate, metallic salts. Attacks metals in moist environments. Also incompatible with salts of alkaloids, chloral hydrate, calomel (mercurous chloride), potassium chlorate, tartaric and other acids, oxidants, diazonium salts, charcoal, ozone, strong reducers, alkali metals, metals (brass, aluminum magnesium, zinc, cadmium, copper, tin, nickel, steel), metallic salts, organic materials, light.

<b>Special Remarks on other Toxic Effects on Humans</b>	Acute Potential Health Effects: Skin: May cause skin irritation. Eyes: May cause eye irritation. Inhalation: May cause respiratory tract and mucous membrane irritation and a productive cough. May cause pulmonary edema and inflammation of the tonsils. Ingestion: Causes gastrointestinal tract irritation with nausea, vomiting and diarrhea. May affect behavior (somnolence, muscle weakness), respiration (dyspnea). Serum-sickness type of hypersensitivity such as fever, arthralgia, lymph node enlargement, and eosinophilia may appear. Furthermore, chronic ingestion of iodides (in animals) during pregnancy has resulted in fetal deaths, severe goiter and cretinoid appearance of the newborn.

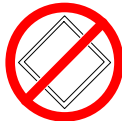

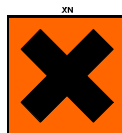
